
RESOLUTION No. _____ (R-77-1858)

Adopted on APR 13 1977

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That for the next 90 days all vacant City-owned land not otherwise committed for specific use during the next 12 month period is hereby reserved for potential use for senior citizen, handicapped and family low-income housing.
2. That the purpose of said 90 day commitment is to enable the Task Force on Senior and Handicapped Low-Income Housing to review each such site for the purpose of rating each such site as to its suitability and desirability for senior citizen, handicapped, and family low-income housing.
3. That upon completion of its site review the Task Force shall submit to the Mayor and City Council a list of City-owned sites, together with the recommendations of the Task Force as to those sites which the Task Force will request the City to reserve solely and specifically for the construction of senior citizen, handicapped and family low-income housing.
4. That the 8 sites included in the Report to the Mayor and Council dated March 2, 1977, a copy of which is attached hereto and by this reference incorporated herein, and the 39 sites identified in a document, a copy of which is attached hereto and incorporated herein and those sites in the marketing catalog in which persons have expressed an interest with the Property Department, are hereby excluded from the above reservation.
5. That the adoption of this resolution does not preclude the City Council from entertaining propositions with regard to any City owned land.
