WHEREAS, an application for transfer of two (2) certificates of public convenience and necessity from WILLIAM J. JENKINS, dba Bill's Cab Company, to ANN CAMPBELL CLEVINGER, dba Bill's Cab Company, to operate taxicabs within the limits of the City of San Diego has been received; and

WHEREAS, pursuant to Section 72.0101(h) of the San Diego Municipal Code, the City Manager has caused an investigation to be made and has reported his findings in writing to this Council; and

WHEREAS, his report indicates, among other things, that the applicant, ANN CAMPBELL CLEVINGER, dba Bill's Cab Company which is wholly owned by Ms. Clevenger whose character and fitness recommend her to engage in the business of operating taxicabs; and

WHEREAS, the Council this date has found the contents of the City Manager's report to be correct and accurate; and

WHEREAS, it is requested that the present operating area be extended south from Carmel Valley Road to La Jolla Village Road and east to the area bordered by a straight line extending south from the junction of El Camino Real and Via de La Valle to the junction of I-805 and La Jolla Village Road; the western border to be the Pacific Ocean; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that the transfer of 2 certificates of public convenience and


necessity for taxicabs, as more particularly set forth above,  
be and it is hereby approved, subject to the following condi-  
tions precedent:

(1) That the transferee comply with all provisions of  
the San Diego Municipal Code.

(2) That the transferee furnish the City Manager and  
City Attorney with satisfactory proof of insurability of  
Bill's Cab Company pursuant to the provisions of the San Diego  
Municipal Code.

BE IT FURTHER RESOLVED, that the present operating area  
be and it is hereby extended south from Carmel Valley Road to  
La Jolla Village Road and east to the area bordered by a  
straight line extending south from the junction of El Camino  
Real and Via de La Valle to the junction of I-805 and La Jolla  
Village Road; the western border to be the Pacific Ocean.
