BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$412,200.00 by Viewland Investment Co., Inc. dba Viewland Construction Company, a corporation, for the CONSTRUCTION OF UNIVERSITY COMMUNITY BRANCH LIBRARY in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 758286.
2. That the expenditure of \$466,000.00 is hereby authorized out of the Capital Outlay Fund (Fund 245) and that the expenditure of \$45,500.00 is hereby authorized out of the Community Buildings Improvement Bond Fund (Fund 726) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF UNIVERSITY COMMUNITY BRANCH LIBRARY in the City of San Diego, and related costs.
