


RESOLUTION No. 218163 (R-77-1836)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$117,394.60 by Conduit Construction Company, a partnership, for the CONSTRUCTION OF OTAY FILTRATION PLANT BY-PASS PIPE in the City of San Diego, California is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 757954.
2. That the expenditure of \$170,000.00 is hereby authorized out of the Water Revenue Fund (Fund 502) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF OTAY FILTRATION PLANT BY-PASS PIPE in the City of San Diego, and related costs.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$30,000.00 within Water Revenue Fund (Fund 502) from the Unallocated Reserve (Fund 69.79) to the Construction Outlay Program (Fund 66.92).
