WHEREAS, certain sewer, drainage and slope easements were acquired for earlier development in the area now included within, and adjacent to, the subdivision now known as Mission Bay View; and

WHEREAS, the present development of the affected property requires realignment of certain existing facilities; and

WHEREAS, these aforementioned facilities no longer serve the purpose for which they were originally constructed; and

WHEREAS, the present easement alignments will conflict with the new layout and street alignment; and

WHEREAS, the City will receive substitute easements where required as granted and shown on the subdivision map of the subdivision known as Mission Bay View; and


WHEREAS, with the approval of the subdivision map of Mission Bay View, the City will no longer have any need for said easements and the City Manager has recommended that the City abandon its interests therein; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City of San Diego by this resolution does hereby abandon whatever right, title or interest it may have in those sewer, drainage, and slope easements as more particularly shown on Drawings 13877-B and 17059-D on file in the office of the City Clerk as Document Nos. 759170 and 759040, consecutively which are by this reference incorporated herein and made a part hereof.

2. That the City Clerk shall cause a certified copy of this resolution, with drawings, attested by him under seal, to be recorded in the office of the County Recorder.
