BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a Lease Agreement with ALBERT W. HUBBARD and MILDRED E. HUBBARD, husband and wife, covering that portion of Lot 9, Block 18, Del Mar Heights Road and Mercado Drive in the Del Mar Heights area for the purpose of providing the Fire Department with a temporary fire station site in the Del Mar Heights area pending the construction on a permanent site, the lease being for a period of three (3) years with two (2) six (6) month options to renew under the same conditions, at a monthly rental of Two Hundred Twenty-Five Dollars (\$225) per month, payable in advance by the first day of each month, under the terms and conditions set forth in the form of lease agreement on file in the office of the City Clerk as Document No. 759021.
