BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the expenditure of \$484,712 from Gas Tax Fund 220 and \$79,000 from Capital Outlay Fund 245 is hereby authorized solely and exclusively for the purpose of providing funds, in addition to those previously allocated, for City's contribution in the total amount of \$1,203,154 for improvements of PALM AVENUE from I-5 to HAWAII AVENUE (Palm Avenue Assessment District), as more particularly described in Resolution of Intention No. 217521 and pursuant to the Municipal Improvement Act of 1913.
