
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the recommendations of the Park and Recreation Board with regard to Concept No. 2, for future development of Belmont Park which Concept No. 2 is described in the report to the Mayor and City Council from the City Manager dated April 19, 1977, a copy of which report is on file in the office of the City Clerk as Document No. 759323, is hereby approved with an amendment to authorize the retention of the carousel in the event such retention is recommended by a consultant to be hired by the City for the purpose of determining the manner of implementing said Concept No. 2.

That the use of Transient Occupancy Tax Funds to hire a consultant to develop said Concept No. 2 as amended is hereby approved in concept.

That the proposed consultant contract shall provide that the consultant shall consider other revenue producing alternatives such as shops, etc., to be included in the prospective park development.
