

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$20,989.50 by DBX Inc., dba Perry Electric, a corporation for the CONSTRUCTION OF A TRAFFIC SIGNAL AND SAFETY LIGHTING SYSTEMS AT THE INTERSECTION OF UNIVERSITY AVENUE AND 8TH AVENUE in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 758022.
2. That the expenditure of \$23,555.00 is hereby authorized out of the Gas Tax Fund (Fund 220) and that the expenditure of \$6,600.00 is hereby authorized out of the Capital Outlay Fund (Fund 245) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF A TRAFFIC SIGNAL AND SAFETY LIGHTING SYSTEMS AT THE INTERSECTION OF UNIVERSITY AVENUE AND 8TH AVENUE in the City of San Diego, and related costs.
