BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. San Diego Toro, 2. Carson Supply Company and 3. Hydro-Scape Products are hereby accepted, and the City Manager is hereby authorized to execute contracts for the purchase of LAWN SPRINKLERS AND SPRINKLER REPAIR PARTS as may be required for a period of one (1) year beginning May 1, 1977 through April 30, 1978 per prices on file in the Purchasing Department as follows:

1. San Diego Toro for Group 1 - Toro Sprinklers and Parts, terms 3% 30 days plus sales tax;
2. Carson Supply Company for Group 11 - (Rainbird Sprinklers and Parts), terms 2% 20 days plus sales tax;
3. Hydro-Scape Products for Group 111 (Buckner Sprinklers and Parts), terms 2% 20 days plus sales tax with an option to renew for an additional one (1) year period subject to an escalation not to exceed 50% of bid prices.
