BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by RAYMOND F. The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that those easements with the right of ingress and egress for the construction and maintenance of sewer, drainage and temporary working area easements, together with the easement and right of way for the natural flowage of waters over, upon and across the portion of Lot 1 as designated as "Flowage Easement Granted Hereon," are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
