APPROVING MAP OF WHITNEY SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by RAYMOND F. HALL, JR., a Registered Civil Engineer, entitled "WHITNEY SUBDIVISION Being a subdivision of a portion of the Northwest Quarter of the Southeast Quarter of Section 27, Township 18 South, Range 2 West, San Bernardino Meridian, in the City of San Diego, County of San Diego, State of California according to the official plat thereof, excepting therefrom that portion of said property described in Deed recorded April 30, 1971 as File/Page No. 89213 lying below a depth of five hundred (500) feet measured vertically from the contour of the surface thereof as said surface existed on March 22, 1971.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities and temporary working area easements, all as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement and right of way for the natural flowage of waters over, upon and across the portion of Lot 1 designated as "Flowage Easement Granted Hereon," as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that those easements with the right of ingress and egress for the construction and maintenance of sewer, drainage and temporary working area easements, together with the easement and right of way for the natural flowage of waters over, upon and across the portion of Lot 1 as designated as "Flowage Easement Granted Hereon," are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
