


RESOLUTION No. 218229 (R-77-1797)

Adopted on **APR 27 1977**

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of SAN DIEGO PRODUCTS COMPANY, a partnership composed of STANLEY E. POTTER and STEPHEN E. POTTER, executed in favor of the City of San Diego, bearing date of January 26, 1977, conveying to said City the permanent easement and right of way to eliminate a title problem that would have been caused by the recording of a previously accepted deed from Stanley E. Potter and Julia C. Potter, authorized January 5, 1977, affecting a portion of Lot 1, of Potter Tract, according to Map thereof No. 5386 filed in the office of the San Diego County Recorder, for the Encanto Trunk Sewer, located north of Imperial Avenue between 54th Street and Euclid Avenue, as more particularly described in said deed, be, and the same is hereby approved.
