

RESOLUTION No. 218238 (R.77-1895)


Adopted on APR 27 1977

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the Water Utilities Director and the Executive Officer of the Southern California Coastal Water Research Project are hereby authorized to travel to Washington, D.C. for a one-week period, anticipated to be during the month of May, 1977, to give testimony to Congressional Staff on proposed additional amendments to PL 92-500 "Federal Water Pollution Control Act Amendments of 1972," and to incur all necessary expenses.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to transfer within Water Operating Fund 500 the sum of \$1,300 from the Unallocated Reserve (69.69) to Utilities Administration (61.10) for the sole and exclusive purpose of providing funds for all incurred expenses in connection with said travel.
