

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to execute a lease with the United States of America, U. S. Department of Justice, Western Regional Office Bureau of Immigration and Naturalization, for use of former San Diego Police Department Juvenile Check Station, San Ysidro, as a facility for the processing and holding of Aliens.

That said property to be leased is located in the Northwest corner of Interstate 5 and the International Boundary, San Ysidro, California, and has an appraised fair market value of \$336,250. A copy of the form of lease is on file in the office of the City Clerk as Document No. 758688.
