That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a second amendment to that certain agreement, as amended, with the SAN DIEGO CONVENTION AND VISITORS' BUREAU, a California nonprofit corporation, by amending paragraph 2b thereof, to authorize an additional \$2,500.00 for the purpose of hosting a San Diego Day for the Association of Mexican Travel Agents Convention in Tijuana on May 5, 1977, all pursuant to the terms and conditions set forth in the form of second amendment to agreement on file in the office of the City Clerk as Document No. 759109.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$2,500.00 within the Transient Occupancy Tax Fund 223 from the Contingency Reserve (52.29) to General Marketing (52.02) for the above purpose.
