That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with GARRETT ECKBO & ASSOCIATES, a landscape architectural firm in San Francisco, for landscape architectural services required for the design of the Black's Beach Access Trail, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 759122.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to expend the sum of \$16,000 from the Capital Outlay Fund 245, solely and exclusively for the purpose of providing funds for the design, soil testing, construction and related expenses of the architectural services described above.
