BE IT FURTHER RESOLVED, THAT IN THE EVENT THE CALIFORNIA OFFICE OF CRIMINAL JUSTICE PLANNING CONSENTS TO FUND THE ABOVE PROJECT FROM FUNDS MADE AVAILABLE THROUGH THE OMNIBUS CRIME CONTROL AND SAFE STREETS ACT, THE CITY OF SAN DIEGO AGREES TO ACCEPT THE GRANT AND DESIGNATES THE CITY ATTORNEY TO EXECUTE AND IMPLEMENT, FOR AND ON BEHALF OF SAID CITY, THE CONTRACT FOR THE GRANT FOR LAW ENFORCEMENT PURPOSES, INCLUDING ANY EXTENSIONS OR AMENDMENTS THEREOF.

BE IT FURTHER RESOLVED, THAT THE CITY OF SAN DIEGO AGREES TO PROVIDE ALL MATCHING FUNDS REQUIRED FOR SAID PROJECT (INCLUDING ANY EXTENSION OR AMENDMENTS THEREOF) UNDER THE SAFE STREETS ACT AND THE RULES AND REGULATIONS OF CCCJ AND THE LAW ENFORCEMENT ASSISTANCE ADMINISTRATION, AND THAT CASH WILL BE APPROPRIATED AS REQUIRED THEREBY.

BE IT FURTHER RESOLVED, THAT GRANT FUNDS RECEIVED
HEREUNDER SHALL NOT BE USED TO SUPPLANT ONGOING LAW ENFORCEMENT
EXPENDITURES.

BE IT FURTHER RESOLVED, THAT THE AUDITOR AND COMPTROLLER BE AND HE IS HEREBY AUTHORIZED TO TRANSFER WITHIN THE GENERAL FUND (100) THE SUM OF \$7,905 FROM THE UNALLOCATED RESERVE (53.31) TO THE ALLOCATED RESERVE (53.20) TO BE USED SOLELY AND EXCLUSIVELY TO MEET CASH MATCH REQUIREMENTS OF THE ABOVE GRANT.
