

RESOLUTION NO. 218273 APR 27 1977. 77-1878

WHEREAS, The City of San Diego from time to time is required to prosecute and defend actions in the Small Claims Division of the Municipal Court of San Diego; and

WHEREAS, the City Attorney is unable to represent the City in said Court because the rules of said Court prohibit the appearance in said Court of an attorney at law; and

WHEREAS, those employees designated to represent the City in Small Claims Court are subject to periodic change owing to turnover and shifts in assignments; and

WHEREAS, the Clerk of Small Claims Court has no objection to Manager-appointed designees; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager be and he is hereby authorized to designate those City employees, as required, to represent The City of San Diego in Small Claims Court actions.

BE IT FURTHER RESOLVED, that Resolution No. 215259 adopted February 4, 1976, be and it is hereby rescinded.
