Leroy Staley	Police	\$ 90	Mr. Staley is a Police Officer. He suggested that certain phones in the Communications Center of the COB be disconnected. This has been done for an estimated annual savings of \$915.
Betty A. Goldberg	City Clerk	\$ 60	Ms. Goldberg is an Intermediate Typist. She suggested that Council and Committee meeting dockets and supplemental dockets be stapled and labeled rather than inserted in interoffice envelopes. This has been found to be a time- saver, and estimated savings are \$624 annually.
Sam A. Jeromin John R. Bardsley	Fire	·	Mr. Jeromin and Mr. Bardsley are Fire Fighters. They developed a hose pack that eliminates some of the difficulties experienced with the old pack. This is a significant safety improvement.
Gayle P. Murrell	Police	\$ 10	Ms. Murrell is a Police Officer. She suggested that a minor revision be made to the Arrest Report. Subject matter on the back of the form was moved to the front to prevent flipping the form back and forth. Savings are \$100 annually.
Linda M. Garfield APPROVED: Jo	Park and Recreation OHN W. WITT. City Attorn	\$ 10	Ms. Garfield is an Intermediate Typist in the Community Services Division. She developed an event logging and scheduling form that is both cheaper to print and easier to handle. Savings are estimated at \$100 per year.
