

RESOLUTION No. 218297 (R. 77-1932)


Adopted on MAY 4 1977

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of PACIFIC COAST BANK, a California corporation, executed in favor of the City of San Diego, bearing date of January 31, 1977, conveying to said City the permanent easement and right of way to construct reconstruct, maintain, operate and repair a public sewer or sewers and a storm drain or drains affecting a portion of Lot 2 of Pacific Coast Bank Plaza, according to Map thereof No. 7108 filed in the Office of the San Diego County Recorder, as more particularly described in said deed, be, and the same is hereby approved.

That the City Clerk is hereby authorized and directed to deliver said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
