

RESOLUTION NO. **218298**

WHEREAS, there were relinquished to The City of San Diego certain abutters' rights of access in and to Mira Mesa Boulevard, over and across a portion of Lot 2, Larwin Square West Unit No. 1, according to Map thereof No. 7928, filed in the San Diego County Recorder's Office April 24, 1974; and

WHEREAS, the owner of the property has requested that the City revert these abutters' rights of access in the property to allow better utilization of the land; and

WHEREAS, said abutters' rights of access are no longer needed by the City and should be reverted in the property; and

WHEREAS, it has been determined that all affected City departments have no objection to the reversion of said abutters' rights; and

WHEREAS, \$65.00 has been collected as the negotiated sale price of the access rights; and

WHEREAS, the City Manager recommends that said access rights be reverted in the property; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of, and as the act and deed of, The City of San Diego, a quitclaim deed, the form of which is on file in the office of the City Clerk

as Document No. 759177, to WALL STREET PROPERTY COMPANY,
a California corporation, effecting the revestment of those
abutters' rights of access to Mira Mesa Boulevard, adjacent to
Lot 2, Larwin Square West Unit No. 1 heretofore relinquished to
the City, as more particularly described in said form of quitclaim
deed.

BE IT FURTHER RESOLVED, that the City Clerk of said City be,
and he is hereby authorized and directed to deliver said deed to
the Property Director of said City for further handling.
