WHEREAS, the approximate 2,300-foot long alley in Prestwick Estates Unit 1, Map 4392, is presently being used as a shortcut between Calle Del Oro and Whale Watch Way and Prestwick Drive in the La Jolla area; and

WHEREAS, the alley currently carries in excess of 400 vehicles per day at speeds higher than those appropriate for an alley; and

WHEREAS, in order to protect the safety and welfare of the public generally, and those persons whose homes front on the alley and use it for access, it is necessary to close a small portion of the alley at its midlength to motor vehicles; and

WHEREAS, such a closing would prevent through traffic by motor vehicles but will continue to allow through access for pedestrians and bicycle traffic; and

WHEREAS, the property owners adjacent to the alley will fund the installation of a gate across the alley in accordance with City standards, which gate will allow the passage of pedestrian and bicycle traffic and which gate will be capable of being opened to allow through traffic by emergency and City trash collection vehicles; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. Pursuant to Section 21101(a) of the Vehicle Code of the State of California, that portion of the alley near its midlength between Calle Del Oro and Whale Watch Way, which

portion is shown on the drawing on file in the office of the City Clerk as Document No. '759214 is determined to be no longer needed for motor vehicle traffic and said portion of the alley is hereby closed to such vehicles.

- 2. The closing shall not be effective until signs giving notice of such closing are posted at both entrances of the alley and until a City-approved gate is installed at the portion to be closed.
- 3. The City Clerk is directed to deliver a certified copy of this resolution to the Engineering and Development Director of The City of San Diego for further handling.
