
BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with MOHLE, PERRY & ASSOCIATES for professional engineering services for the design of traffic signal and safety lighting systems and intersection realignment at FRIARS ROAD, MISSION GORGE ROAD and ZION AVENUE, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 759178.

2. That the City Auditor and Comptroller be and he is hereby authorized to transfer \$10,000 from Gas Tax Fund Reserve CIP 90-220(7) to CIP 62-129(7) for the purpose of immediately retaining a design consultant and other City costs incurred in connection with the above-referenced project.

3. That the expenditure of \$5,500 is hereby authorized out of Gas Tax Fund CIP 62-129(7) of The City of San Diego solely and exclusively for the purpose of providing funds for the above-referenced design services.
