BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$809,058.50 by Daley Corporation, a corporation, for THE IMPROVEMENT OF 47th STREET - SOUTH CITY LIMITS TO HARTLEY STREET AND LOGAN AVENUE - 45th STREET TO 49th STREET, including Addenda A and A1, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 758587.
2. That the expenditure of \$690,570.00 is hereby authorized out of the Gas Tax Fund (Fund 220), that the expenditure of \$227,749.00 is hereby authorized out of the Capital Outlay Fund (Fund 245), and that the expenditure of \$1,830.00 is hereby authorized out of the Water Revenue Fund (Fund 502) of the City of San Diego solely and exclusively for the purpose of providing funds for THE IMPROVEMENT OF 47th STREET - SOUTH CITY LIMITS TO HARTLEY STREET AND LOGAN AVENUE - 45th STREET TO 49th STREET, including Addenda A and A1, in the City of San Diego, and related costs.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$102,251.00 from CIP No. 52-075 to Capital Outlay Reserve, CIP No. 90-245.
