That the acceptance by the City Manager of that deed of GEORGE W. KUYBUS and GUADALUPE KUYBUS, husband and wife, as joint tenants, executed in favor of The City of San Diego, bearing date of March 18, 1977, conveying to said City for public purposes an easement over all that portion of the Northwest Quarter of the Northeast Quarter of Section 26, Township 18 South, Range 2 West, San Bernardino Base and Meridian in the County of San Diego, State of California, according to United States Government Survey as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed as Parcel 1 and Parcel 2 are hereby dedicated as and for a public street and the same is hereby named PICADOR BOULEVARD.

That the City Clerk is hereby authorized and directed to deliver said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
