A RESOLUTION OF THE CITY COUNCIL OF THE CITY  
OF SAN DIEGO APPROVING AND PROVIDING FOR THE  
EXECUTION OF A PROJECT AGREEMENT FOR ROBERTI-  
Z'BERG URBAN OPEN-SPACE AND RECREATION PROGRAM

BE IT RESOLVED, by the Council of The City of San Diego  
as follows:

1. The Project Agreement filed with the City Clerk as  
Document No. 759310 between The City of San Diego  
and the State of California, under the terms of which provi-  
sion is made for state reimbursement of an amount not to exceed  
\$746,827 under provisions of the Roberti-Z'berg Urban Open-  
Space and Recreation Program for the development of Projects  
Nos. CIP #29-274 - Highland and Landis District Neighborhood  
Park Acquisition, CIP #29-183 - Montgomery-Waller District  
Neighborhood Park Acquisition, CIP #29-264 - South Bay Terrace  
Neighborhood Park Acquisition, CIP #29-238 - Linda Vista  
District Neighborhood Park Acquisition and CIP #21-409.1 -  
Morley Field East Development, as described below:

- a. CIP #29-274 - Acquisition of approximately  
5 acres for a neighborhood park,
- b. CIP #29-183 - Acquisition of approximately  
10 acres for a neighborhood park,
- c. CIP #29-264 - Acquisition of approximately  
6 acres for a neighborhood park,
- d. CIP #29-238 - Acquisition of approximately  
5 acres for a neighborhood park,

e. CIP #21-409.1 - Development of approximately ten acres as a passive recreation area. Development to include a group picnic area with barbecues and storage area, play equipment, irrigation, landscaping, play lawn and replacement of an existing road with a bicycle/pedestrian path,  
is hereby approved in all respects.

2. The City Manager of The City of San Diego is hereby authorized and directed to execute five copies of said Project Agreement.

3. The City Clerk shall certify to the passage of this resolution by The City of San Diego and it shall thereupon take effect.
