

RESOLUTION NO. 218357

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That fees and surcharges for the use of the municipal golf courses located in Torrey Pines Park and Balboa Park be established as follows:

Said Torrey Pines monthly ticket entitles holder to play a maximum of 15 rounds of golf per month at Balboa Park or Torrey Pines Golf Courses except that said ticket shall not be limited in rounds played if purchaser is 62 years of age or older and that said ticket shall be subject to the green fee charges listed above when used Saturdays, Sundays or Legal Holidays, and shall be further subject to reasonable rules and regulations of the golf course management.

Monthly Coupon Book - Torrey Pines

Monthly Charge

\$40.00
(Includes \$5.00 Surcharge)

Said coupon book shall authorize purchaser only to play ten 18-hole rounds of golf per month, weekdays at Torrey Pines without payment of additional fees. Coupons will be honored on weekends and holidays for afternoon play upon payment of a \$1.50 surcharge. Coupon book is nontransferable and play tickets will be accepted for a one-calendar-month period starting on the date of purchase.

Said monthly ticket entitles holder to play a maximum of 15 rounds of golf per month at the Balboa Park Golf Course, except that said ticket shall not be limited in rounds played if purchaser is 62 years of age or older and that said ticket shall be subject to the green fee charges as listed above when used on Saturdays, Sundays and Legal Holidays, and shall be further subject to reasonable rules and regulations of the golf course management.

Resident

9 Hole Course (for residents or property taxpayers)

\$ 7.50

Nonresident

9 Hole Course (for those who are not residents or property taxpayers)

\$10.00

Said monthly ticket entitles holder to play a maximum of nine holes of golf per day at Balboa Park 9 Hole Golf Course only, except that said ticket shall not be valid on Saturdays, Sundays or Legal Holidays.

Student Monthly Ticket

Monthly Charge

\$ 3.50

Said Student Monthly Ticket entitles elementary, junior and senior high school students, from schools located in the City of San Diego, who have not yet reached their eighteenth birthdays to play a maximum of eighteen holes of golf on weekdays only, subject to rules and regulations of management on any municipal golf course. Student tickets may also be issued to members

of any golf team representing collegiate level institutions located in the City of San Diego for the competitive golf season only.

City Resident I.D. Card

Annual Fee

\$ 1.00

Said green fee and monthly ticket rates for "Residents" shall be charged to golfers showing an identification card indicating they reside or are property taxpayers in the City of San Diego.

County Resident I.D. Card

Annual Fee

\$ 2.00

Said monthly ticket rates for those who do not reside or pay property taxes in the City of San Diego but reside within the limits of San Diego County shall be authorized upon showing an identification card as proof of San Diego County residency.

BE IT FURTHER RESOLVED, that the Park and Recreation Department is hereby authorized to select five "home" student golf teams of six members each from junior high schools, senior high schools and colleges in the City of San Diego for play at Balboa and the same number for play at Torrey Pines. Subject to scheduling by the course management, with each team member required to purchase a student monthly ticket, match contests may be arranged at both courses between such student teams and student teams of like number of members "visiting" teams chosen from other junior and senior high schools or colleges and, further, to arrange reciprocal waiving of green fees and the reciprocal honoring of monthly student tickets with their respective "home" courses, provided that team matches shall start at the discretion of the course management, are limited to one match of two teams on any school day except Wednesday when there shall be no team matches.

BE IT FURTHER RESOLVED, that the Park and Recreation Department is hereby authorized to waive green fees for contestants entered in the annual Junior Golf Championships held at any municipal golf course.

BE IT FURTHER RESOLVED, that the Park and Recreation Department is hereby authorized to waive green fees for contestants entered in the Annual Andy Williams San Diego Open Golf Tournament at Torrey Pines and contestants in final round competition to determine the San Diego City Men's Amateur, Women's Amateur and Senior Citizen Championships.


BE IT FURTHER RESOLVED, that for the purpose of this resolution, Legal Holidays are defined in San Diego Municipal Code Section 21.04.

BE IT FURTHER RESOLVED, that the City Auditor is hereby directed to deposit the revenues accumulated from the above surcharge amounts for use of the Torrey Pines Golf Course into a special fund to be used to partially reimburse Fund 245 (Capital Outlay Fund) for the expenses necessary to automate the irrigation system at Torrey Pines Golf Course.

BE IT FURTHER RESOLVED, that Resolution No. 210916, adopted June 20, 1974, be and the same is hereby rescinded.

BE IT FURTHER RESOLVED, that this resolution shall become effective June 1, 1977.
