AUTHORIZING THE SAN DIEGO COUNTY DIRECTOR OF PUBLIC HEALTH TO ENFORCE THE PROVISIONS OF ORDINANCE NO. 11652 (NEW SERIES) RELATING TO THE CONSTRUCTION, REPAIR, RECONSTRUCTION OR DESTRUCTION OF WELLS WITHIN THE CITY OF SAN DIEGO.

WHEREAS, The City of San Diego has heretofore, by Resolution No. 110405 adopted January 27, 1953, entered into an agreement with The County of San Diego providing for the County to carry out public health services in the City of San Diego, including enforcement by appropriate County officials of certain City ordinances relating to public health; and

WHEREAS, the City, on July 16, 1975, adopted Ordinance No. 11652 (New Series) relating to the construction, repair, reconstruction or destruction of wells, which ordinance stipulates that the San Diego County Director of Public Health shall be the enforcing officer; and

WHEREAS, it is now necessary for the City Council to request that the San Diego County Director of Public Health enforce the provisions of Ordinance No. 11652 (New Series); NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Council does hereby formally request the Board of Supervisors to direct the San Diego County Director of Public Health to enforce the provisions of Ordinance No. 11652 (New Series) in the City of San Diego.

BE IT FURTHER RESOLVED, that the City does hereby authorize said appropriate County officials and employees to enforce said ordinance within the incorporated area of the City.

BE IT FURTHER RESOLVED, that the City Council does hereby certify that said Ordinance No. 11652 (New Series) is comparable and compatible with the County ordinance relating to the construction, repair, reconstruction or destruction of wells.

BE IT FURTHER RESOLVED, that the City Clerk of The City of San Diego be and he is hereby authorized and directed to forward a certified copy of this resolution to the San Diego County Board of Supervisors.
