WHEREAS, The City of San Diego has heretofore, by Resolution No. 110405, adopted January 27, 1953, entered into an agreement with The County of San Diego providing for the County to carry out public health services in the City of San Diego, including enforcement by appropriate County officials of certain City ordinances relating to public health; and

WHEREAS, the City, on MAY 25, 1977, adopted Ordinance No. 12074 (New Series) relating to the operation of public swimming pools; Ordinance No. 12075 (New Series) relating to the installation and repair of cesspools, septic tanks and subsurface disposal systems and Ordinance No. 12073 (New Series) relating to permit fees for Food Handling Establishments; and

WHEREAS, it is now necessary for the City Council to request that the San Diego County Director of Public Health enforce the provisions of said ordinances; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Council does hereby formally request the Board of Supervisors to direct the San Diego County Director of Public Health to enforce the provisions of said ordinances in the City of San Diego.

BE IT FURTHER RESOLVED, that the City does hereby authorize said appropriate County officials and employees to enforce said ordinances within the incorporated area of the City.

BE IT FURTHER RESOLVED, that the City Clerk of The City of San Diego be and he is hereby authorized and directed to forward a certified copy of this resolution to the San Diego County Board of Supervisors.
