

RESOLUTION NO. 218372

(R. 77-2107)

MAY 11 1977

WHEREAS, upon the unanimous recommendation of its Planning Commission, the City Council of The City of San Diego, on February 23, 1977, unanimously adopted the position that it would not support legislation to amend the California Coastal Act of 1976 to include all of the La Jolla or any other community into the Coastal Zone; and

WHEREAS, AB 1067 introduced by Assemblyman Kapiloff on March 23, 1977, proposes to amend the California Coastal Act of 1976 to include scattered portions of the La Jolla, Pacific Beach, Clairemont, Midway and Peninsula communities into the Coastal Zone; and

WHEREAS, the City Council of The City of San Diego recognizes that the California Coastal Commission has reviewed AB 1067 and officially opposes its enactment to amend the Coastal Zone boundary in San Diego principally because of its precedent-setting nature; and

WHEREAS, the City Council of The City of San Diego has reviewed AB 1067 in view of its prior position not to support amendments to the Coastal Zone; and

WHEREAS, the City Council of The City of San Diego continues to view such amendments as precedent-setting in terms of further modifications to the Coastal Zone boundary throughout the State's thousand-mile coastline; and

WHEREAS, the City Council of The City of San Diego considers AB 1067 as proposing piecemeal amendments within the City itself, and fails to comprehensively examine the appropriateness of the Coastal Zone throughout the City; and

WHEREAS, the City Council of The City of San Diego in reviewing AB 1067 finds no supporting justification for the scattered Coastal Zone boundary realignments, excepting to utilize a uniform, albeit arbitrary, 1,000-yard line previously established under Proposition 20; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of The City of San Diego, that it reaffirms its position not to support legislation to amend the Coastal Zone boundary as defined in the California Coastal Act of 1976.
