1. That the bid of \$9,093.60 by Modern Alloys, Inc., a corporation, for the IMPROVEMENT OF CARMEL MOUNTAIN ROAD FROM VIA RIMINI TO 1,000' SOUTHERLY - METAL BEAM GUARDRAIL in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 758778.
2. That the expenditure of \$11,175.00 is hereby authorized out of the Gas Tax Funds (Fund 220) and that the expenditure of \$2,594.00 is hereby authorized out of the Capital Outlay Funds (Fund 245) of the City of San Diego solely and exclusively for the purpose of providing funds for IMPROVEMENT OF CARMEL MOUNTAIN ROAD FROM VIA RIMINI TO 1,000' SOUTHERLY - METAL BEAM GUARDRAIL in the City of San Diego, and related costs.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$11,825.00 from CIP No. 52-094.8(7) to Gas Tax Unallocated Reserve, CIP 90-220.
