

RESOLUTION NO. 218399

(R. 77-2021)

WHEREAS, certain sewer and general utility easements were acquired for an earlier development in the area now included within, and adjacent to, the subdivision now known as GLIDDEN COURT SUBDIVISION, UNIT NO. 2; and

WHEREAS, the present development of the affected property requires realignment of certain existing facilities; and

WHEREAS, the present easement alignments will conflict with the new lot layout and street alignment; and

WHEREAS, the City will receive substitute easements granted and shown on the subdivision map of the subdivision known as GLIDDEN COURT SUBDIVISION, UNIT NO. 2; and

WHEREAS, with the approval of the subdivision map of GLIDDEN COURT SUBDIVISION UNIT NO. 2, the City will no longer have any need for said easements and the City Manager has recommended that the City abandon its interests therein; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City of San Diego by this resolution does hereby abandon whatever right, title or interest it may have in those sewer and general utility easements as more particularly shown on Drawing No. 17165-D on file in the office of the City Clerk as Document No. 759346, which is by this reference incorporated herein and made a part hereof.

2. That the City Clerk shall cause a certified copy of this resolution, with drawings, attested by him under seal, to be recorded in the office of the County Recorder.
