

RESOLUTION No. 218105 (R.77-2046)

Adopted on MAY 18 1977

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, Utilities Agreement No. 12548 with the STATE DEPARTMENT OF TRANSPORTATION for the relocation of water facilities on Route 8, between 0.8 mile west of Route 15 to College Avenue, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 759344.

BE IT FURTHER RESOLVED, that the expenditure of \$36,337 is hereby authorized out of Water Revenue Fund 502 for the sole and exclusive purpose of providing funds for depreciation credits for said project; and the expenditure of \$29,000 is hereby authorized out of Water Revenue Fund 502, for the sole and exclusive purpose of providing funds for preliminary engineering work to be performed for said project, said sum to be reimbursed by the State.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered to do by City Forces all necessary work in conjunction with the relocation of said water facilities, the cost of which shall not exceed \$28,000 and is reimbursable by the State, pursuant to the recommendation of the City Manager and the submission of his estimates indicating that said work can be done more economically by City Forces than if let by contract.
