BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, Utilities Agreement No. 12549 with the STATE DEPARTMENT OF TRANSPORTATION for the relocation of sewer facilities on Route 8, between 0.8 mile west of Route 15 to College Avenue, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 759347.

BE IT FURTHER RESOLVED, that the expenditure of \$48,000 is hereby authorized out of Sewer Revenue Fund 506, for the sole and exclusive purpose of providing funds for preliminary engineering work to be performed for said project, said sum to be reimbursed by the State; and the expenditure of \$6,010 is hereby authorized out of Sewer Revenue Fund 506, for the sole and exclusive purpose of providing funds for the betterment of said sewer facilities for said project.
