

RESOLUTION No. 218419 (R. 77-2018)


Adopted on MAY 18 1977

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized to execute a six-month agreement with the Housing Elderly and Low-Income People (HELP) Committee, an unincorporated association, the form of which is on file in the office of the City Clerk as Document No. 759361, with regard to approximately 10 acres located at Interstate 805 and Belden Street, whereby the Committee is granted the exclusive right to be recognized by City as the entity which shall plan for the development of the premises for future use as a low-income homeownership residential project.
