APPROVING MAP OF PLAZA MAYOR UNIT NO. 1

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed by W. R. NOTHOMB, a Licensed Land Surveyor, entitled "PLAZA MAYOR UNIT NO. 1 Being a subdivision of portions of Lots 11 through 14, inclusive, 31 through 34, inclusive, and all of Lots 15 through 30, inclusive, in Block 5; portions of Lots 2 through 5, inclusive, 40 through 43, inclusive, and all of Lots 6 through 39, inclusive, in Block 6; all of Lots 25 through 48, inclusive, in Block 7; portions of Lots 46, 47 and 48 in Block 15; and portions of Lots 5 thorough 12, inclusive, 32 through 36, inclusive, all of Lots 1 through 4, inclusive, and all of Lots 37 through 48, inclusive, in Block 16; all of Tia Juana City, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 562, filed in the office of the County Recorder of said San Diego County, August 29, 1888, together with via Nacional (formerly National Avenue), Louisiana Avenue, Ensenada Street, Front Street, the Alleys in Blocks 5, 6 and 16 and portions of Virginia Avenue and the Alley in Block 7 of said Tia Juana City as closed and vacated to public use." is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public a portion of Avenida Camiones for public purposes;

and said portion of a street is hereby declared to be a portion of a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the easements listed in paragraphs 1 and 2 of the Owner's certificate, as shown on this map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portion of a public street is accepted on behalf of the public as heretofore stated; and that those easements listed in paragraphs 1 and 2 of the Owner's certificate, as granted and shown on this map, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
