BE IT FURTHER RESOLVED, that Bond No. 5985349, issued by the FIDELITY AND DEPOSIT COMPANY OF MARYLAND, in the amount of \$152,000.00, is hereby accepted as improvement security for the performance of the public improvements, and that the Instrument of Credit issued by California First Bank, is hereby released.
