

**RESOLUTION No. 218456** (R-77-1982 )


Adopted on MAY 25 1977

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a Lease Agreement with THE UNITED STATES OF AMERICA, as Lessee, leasing a portion of The "Outer Marker" antenna site, located on the vacant land on the Alvarado Filtration Plant Facility Site, consisting of 2,831 square feet, for the use in conjunction with The Montgomery Field "Localizer" antenna site, under the terms and conditions set forth in the form of lease agreement on file in the office of the City Clerk as Document No. 759460, said property having a value of \$5,000 as established by a Property Department staff appraiser.

That the City Clerk is hereby authorized and directed to deliver said lease agreement and a certified copy of this resolution to the Property Director for further handling.
