WHEREAS, Resolution No. 211718 adopted October 3, 1974 authorized the City Manager to execute a Capital Grant Contract with the URBAN MASS TRANSPORTATION ADMINISTRATION (UTMA) in the amount of \$2,765,815 for the purchase of equipment to be used by the San Diego Transit Corporation; and

WHEREAS, said resolution authorized cost sharing under the grant project as 80% as the federal share (\$2,212,652) and 20% as the local share (\$553,163); and

WHEREAS, said local share calculation of \$553,163 included an amount of \$25,980 to be used towards payment of 1% of the California sales tax, which amount is returned to the City; and

WHEREAS, the \$25,980 to be used as payment of the 1% sales tax was not an eligible expenditure for the purposes of calculating the local share contribution under the grant contract; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that the City Auditor and Comptroller is hereby authorized to transfer the additional sum of \$25,980 from Public Transportation Reserve Fund 2571 to Transit System Purchase 55 Buses Fund 2576 to provide for the 1% of sales tax not otherwise eligible pursuant to the grant contract.
