Policy Nos. 600-5 and 600-24, policies of The City of San Diego with respect to community plans; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

The Scripps Miramar Ranch Planning Committee be, and it is hereby authorized to represent the Scripps Miramar Ranch Community, consisting of the area included within the area of a map identified as Exhibit A, attached hereto as a part hereof; work with the City Manager's office and Planning Department in the development of a long-range community plan consistent with community goals and objectives; and be responsible for its presentation, as well as the coordination of community support for its adoption and effectuation.
