BE IT RESOLVED, by the Council of The City of San Diego as follows: *F77-2116*

That the bid of Case Power & Equipment is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of four (4) RUBBER TIRED TRACTOR LOADERS. Two at a cost of \$25,415.00 each for a total cost of \$50,830.00; terms net 30 days plus sales tax, less trade in allowance of \$2,950.00 and \$4,950.00 for two (2) used loaders with guaranteed repurchase at 8000 hours or 5 years of \$15,885.00 each; two at a cost of \$27,815.00 each for a total cost of \$55,630.00; terms net 30 days plus sales tax, less trade-in allowance of \$4,950.00 and \$6,950.00 for two (2) used loaders with a guaranteed repurchase at 8000 hours or 5 years of \$17,385.00 each.
