

RESOLUTION No. 218494 (R-77-2123)


Adopted on JUN 1 1977

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. San Diego Pipe and Supply, 2. Keenan Pipe & Supply Company, and 3. Industries Supply Co. are hereby accepted, and the City Manager is hereby authorized to execute contracts for the purchase of PIPE, FITTINGS AND MISCELLANEOUS PLUMBING SUPPLIES as may be required for a period of one (1) year beginning July 1, 1977 through June 30, 1978, per prices on file in the Purchasing Department as follows:

1. San Diego Pipe and Supply for Sections I and II, terms 2% 30 days plus sales tax with an option to renew for an additional one (1) year period at bid prices subject to escalation not to exceed 25% of bid price during option period,
2. Keenan Pipe & Supply Company for Sections III and IV, terms 2% 30 days plus sales tax with an option to renew for an additional one (1) year period at bid prices subject to escalation not to exceed 10% of bid price during option year, and
3. Industries Supply Co. for Section V, terms 2% 30 days plus sales tax.
