

That the acceptance by the City Manager of that grant and slope easement deed of GEORGE W. KUYBUS, SR., Conservator for FLORENCE M. ABEL, executed in favor of The City of San Diego, bearing date of April 12, 1977, conveying to said City for public purposes an easement over all that portion of the Northwest Quarter of the Northeast Quarter of Section 26, Township 18 South, Range 2 West, San Bernardino Base and Meridian in the County of San Diego, State of California, according to United States Government Survey as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed as Parcel 1 is hereby dedicated as and for a public street and the same is hereby named PICADOR BOULEVARD.

That the City Clerk is hereby authorized and directed to deliver said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
