

RESOLUTION NO. 218515 R. 77-2136

WHEREAS, the Saline Water Distribution Line ("Line") was acquired by The City of San Diego ("City") for the sum of \$1.00 from the State of California, Department of Water Resources as part of an agreement to purchase miscellaneous steel pipe, and 12-inch and 16-inch underground pipeline and appurtenances on South San Diego Bay; and

WHEREAS, the sale was a result of termination of use of the saline water conversion facility by the U.S. Department of Interior, Office of Saline Water; and

WHEREAS, the Line originates near Moss Street extended and Bay Boulevard in Chula Vista and connects to the California-American Water Company's Highland Tank located on Palm Avenue near National Avenue in Palm City; and

WHEREAS, the California-American Water Company, who is the sole supplier of water in this area and also owns and operates a water well known as Otay Well Number 8, which is adjacent to the Line, has a use for and wishes to purchase said Line; and


WHEREAS, the City has no present use and anticipates no future use of the Line and the staff is recommending the sale of the Line for a negotiated price of \$4,000; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with CALIFORNIA-AMERICAN WATER COMPANY for the sale of the City-owned Saline Water Distribution Line to the California-American

Water Company for the sum of \$4,000, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 759510.
