
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That Change Order No. 2, dated May 19, 1977, heretofore filed with the City Clerk of said City as Document No. 759536, issued in connection with the contract between The City of San Diego and Metro-Young Construction Company for the CONSTRUCTION OF SEWER MAIN REPLACEMENT GROUP 41, said contract having been filed in the office of the City Clerk as Document No. 757340, be and the same is hereby approved; and the changes therein set forth, amounting to an increase in the contract price of \$60,000 and an extension of time of 61 days extending the completion date to July 22, 1977, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the expenditure of \$60,000 out of Sewer Revenue Fund 506 of The City of San Diego is hereby authorized, solely and exclusively, for this purpose and related costs.
