WHEREAS, The City of San Diego, California, has entered into a contract with the U. S. Department of Housing and Urban Development (HUD) to carry out, within the City of San Diego, a housing and community development program; and


WHEREAS, the successful implementation of the Horton Plaza Redevelopment Project in the downtown area requires the use of block grant funds in the estimated amount of \$1,085,000 for the purpose of land acquisition and relocation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Auditor and Comptroller is hereby authorized to transfer the sum of \$1,085,000 from Block Grant Fund 2930 to Redevelopment Fund 984 for the purpose of acquiring six (6) lots consisting of Lots A, B, C, J, K and L, Block 68, in Horton's Addition, plus necessary relocation and other expenses connected therewith.

2. Said transfer of funds shall be considered as an advance to be repaid from future tax increments or other appropriate sources as such funds become available.
