BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be, and he is hereby authorized to execute, for and on behalf of said City, twenty-four (24) first amendments to agreements with community agencies and one second amendment to agreement with the San Diego Unified School District for the purpose of continuing for two months various social programs for the period from July 1, 1977 to August 31, 1977, and to commit \$121,931 in Fiscal Year '78 Revenue Sharing moneys and \$34,812 in Fiscal Year '77 Revenue Sharing savings for this purpose.

The social programs, agencies, contract amount and contract document numbers shall be as contained in the forms of amendments to agreements on file in the office of the City Clerk as follows:
