


RESOLUTION NO. 218524 (R. 77-2267)

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, first amendments to agreements with the following community agencies for the purpose of continuing for two months the following public service programs for the period from July 1, 1977 to August 31, 1977, with Community Development Block Grant (CDBG) funds, and to commit \$172,583 in 1977 CDBG Public Service moneys for this purpose, pursuant to the terms and conditions set forth in the form of each amendment to agreement as follows:
