


RESOLUTION No. 218535 (R-77-2342)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$149,185.40 by T. B. Penick & Sons, Inc., a corporation, for THE IMPROVEMENT OF COTTONWOOD STREET, OSBORN STREET, ETA STREET, WODEN STREET AND YAMA STREET, CONTRACT NO. 1, including Addenda A and B, in the City of San Diego, California is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 758670.
2. That the expenditure of \$187,000.00 is hereby authorized out of the First Year Block Grant Fund (Fund 2910) and that the expenditure of \$6,900.00 is hereby authorized out of the Capital Outlay Fund (Fund 245) of the City of San Diego solely and exclusively for the purpose of providing funds for THE IMPROVEMENT OF COTTONWOOD STREET, OSBORN STREET, ETA STREET, WODEN STREET AND YAMA STREET, CONTRACT NO. 1, including Addenda A and B, in the City of San Diego, and related costs.
